ASSET DEFINITIONS

Other Investments include:

- trust funds
- money market funds
- certificates of deposit
- stocks/bonds
- Coverdell savings accounts
- college savings plans
- installment and land sale contracts

Please do not include the cash value or built-up equity of a life insurance policy or pension plan.
