# General Information

## Am I Eligible

All registered full-time traditional Undergraduate students (12 credits or more) will automatically be enrolled in and billed for the Student Health Insurance Plan offered by Champlain College unless the student completes an online waiver by August 15, 2024.

## Dependents

Insured Students who are enrolled in the Student Health Insurance Plan may also enroll their eligible Dependents.

## How Do I Waive/Enroll?

If You are eligible to be covered under this Plan, You are automatically enrolled, unless You waive coverage. To document proof of comparable coverage, students need to complete the online Waiver Form and submit it prior to the start of the school year. The deadline to waive for the annual coverage is August 01, 2024. To submit the online Waiver Form:

- Next click on the Waiver tab;
- Review Champlain College's Online Waiver Disclosure Acknowledgement;
