General Information

Am I Eligible

All registered full-time traditional Undergraduate students (12 credits or more) will automatically be enrolled in and billed for the Student Health Insurance Plan offered by Champlain College unless the student completes an online waiver by August 1, 2026.

Dependents

Insured Students who are enrolled in the Student Health Insurance Plan may also enroll their eligible Dependents.

How Do I Waive/Enroll?

If You are eligible to be covered under this Plan, You are automatically enrolled, unless You waive coverage. To document proof of comparable coverage, students need to complete the online Waiver Form and submit it prior to the start of the school year. The deadline to waive for the annual coverage is August 1, 2026. To submit the online Waiver Form:

- Go to www.wellfleetstudent.com;
- Start by selecting Champlain College from the drop-down box;
- Next click on the Waiver tab;
- Review Champlain College's Online Waiver Disclosure Acknowledgement;
- Click "Continue"; and proceed as directed.
- **Please Note:** Waivers are required to be completed for each plan year.

To Purchase coverage and Enroll your dependents:

- Go to www.wellfleetstudent.com.
- Select Champlain College
- Click the "Enroll" tab and proceed as directed to enroll in and purchase the student health insurance plan.

The deadline to enroll and purchase coverage for Annual coverage is August 1, 2026.

Pre-Certification Requirement:

8. Complex Imaging;
9. Fertility Preservation;
10. (Infusion Therapy when administered in the home as part of Home Health Care only);
11. Botox Injections;
12. Genetic Testing, except for BRCA;
13. Orthotics/Prosthetics over \$500 per item;
14. Non-emergency air Ambulance (fixed wing);
15. Outpatient Private Duty Nursing;
16. Chiropractic Services (Outpatient) Pre-Certification required after the 24th visit.

Primary Care Physicians (PCP) are not subjected to Pre-Certification requirements.
